Call to Order: Ken Zook, President, called the meeting to order at 10:50 a.m.

<u>MOTION:</u> Chuck Strode made a motion to approve the January 10, 2019 meeting minutes as submitted. The motion was seconded by Matt Vice and passed unanimously.

Financial Report - Leslie Ellis

Leslie just recently received files and credentials since becoming the new Treasurer and will defer reporting until the next meeting. Leslie did note that she has not been able to locate all financial records from a period dating back to three years. Reini to discuss with Bill Jackson, past Treasurer during that time to locate records needed.

Kent mentioned storage of historical and current Chapter data and records to insure proper security and backup of electronic files procedures are in place should be reviewed to insure adequate measures are in place. Also adequate procedures must be in place for controlled access. Reini mentioned that Overflow Design Group, the company that does the web site may be a good source for storing data securely. Kent mentioned that he would look into other resources that might be a viable way to do a quick review of what is in place versus what we should have in place at a minimum.

Financial Committee Charter – Robert Taylor

Robert reported that he is working to finalize the previously approved changes to incorporate the new Chapter policy for Contingency Funding and Cash & Investment Policy into the existing financial management and investment policy operating procedures.
